CITY RECEIVES FAVORABLE RATINGS FROM MOODY'S, STANDARDS & Poor's credit agencies

oody's Investor Services' and Standard and Poor's newly-released Credit Rating report reaffirms the City of Broken Arrow's outstanding credit rating with each agency.

According to Moody's latest credit opinion, which gives the City an Aa2 rating, "reflects a sizeable tax base in the Tulsa metropolitan

area, and a history of satisfactory financial management with adequate, though somewhat narrow, reserves."

The rating also incorporates the city's exposure to variable rate debt and interest rate derivatives.

"We are very pleased the City has maintained its strong credit rating," said Mayor Craig Thurmond. "A favorable rating from two of the world's leading credit agencies provides investors, and the community, the confidence in the financial leadership and management of this municipality."

The Moody's report notes a substantial tax base located within the Tulsa Metropolitan Statistical Area, above average socioeconomic profile and a history of stable General Fund reserves as strengths.

The S&P rating also proved favorable with an AA-stable rating.

"A strong rating allows for a lower interest rate from banks and other financial institutions, which places the City in a stronger financial position," said City Finance Director Tom Caldwell. "The stronger the City's financial position, the more resources can be allocated to improve the City's infrastructure."

This report equates the AA-stable rating to the following:

• Adequate economy with participation in

the Tulsa metropolitan statistical area (MSA);
• Adequate budgetary

• Adequate budgetary flexibility

- Adequate budgetary performance
- Adequate debt and liability profile
- Adequate management conditions
- Strong Institutional Framework

While the City's credit

ratings are in good standing, there are still challenges ahead.

Like other Oklahoma cities, Broken Arrow is largely dependent on sales taxes as its main revenue stream based on the state constitution. In fiscal year 2011, sales taxes accounted for 52.7 percent of General Fund operating revenues. Overall, the city levies a 3 percent sales and use tax and designates 1.5 percent of the receipts to general purposes, 1 percent pledged to the municipal utility authority, and 0.5 percent designated for capital improvements.

"With such erratic revenue fluctuations, the City must continue to be cognizant of where tax-payer dollars are being spent," City Manager Moton said. "We must also continue to explore more resilient revenue streams that can enhance the City's ability to provide infrastructure and services. The City's management team will continue in its efforts to continue building the City's Emergency Reserve Fund, as well."

Despite the national economic downturn, the city's sales tax receipts have remained relatively strong, averaging 3.9 percent annually over the past five years. In fiscal year 2013, sales tax was 6.3 percent higher than the prior year's. The fiscal year 2014 budget included an increase of 4.5 percent.

2014 City holiday schedule

The city of Broken Arrow has announced its holiday schedule for 2014.

City offices will be closed Jan. 1 and on Martin Luther King Jr. Day, Jan. 20.

Other holidays include Good Friday, April 18; Memorial Day, May 26; Independence Day, July 4; Labor Day, Sept. 1; Veteran's Day Nov. 11; Thanksgiving, Nov. 27 and 28; and Christmas, Dec. 25.

City employees will be off on those days, with the exception of some police and fire department personnel.

City hall and other city facilities will be closed.

On those holidays which fall on Monday, the curbside trash pickup schedule will be changed with Monday and Thursday customers having service on Tuesday and Thursday, and Tuesday and Friday customers on Wednesday and Friday.

When holidays fall on other days of the week, service will resume on the residents next scheduled day.



Prevent water lines from freezing

DURING WINTER MONTHS

The City is encouraging residents to take the following precautions to prevent water lines from freezing.

- 1. Open any cabinet doors to allow warm air under the sink area.
- 2. Let water drip from faucets that are against outside walls. Moving water does not freeze as quickly as still water.
- 3. If you live in a mobile home, be sure the aprons are placed properly to prevent cold air from blowing under the structure.
- 4. Any pipes that are exposed to the cold need to be insulated to prevent freezing.
- 5. Be sure all garden hoses are unhooked from the outside faucet.

The Action Center will respond to calls involving water lines on the City's side of the meters.

If a problem persists on the residents side and into the house, the customer must correct the problem themselves or call a plumber to address the problem.

BAPD to offer free motorcycle course

The Broken Arrow Police Department will provide a motorcycle survival training course free to the public.
