(Appointment System for Accessing Permanent Disposal Facility)

Household products (cleaners, solvents, pesticides, etc.) should be properly used up, whenever possible. However, there are times when a disposal option is necessary. In the past, The M.e.t. has hosted a bi-annual pollutant collection event.

Now, the City of Tulsa has a permanent facility for use by the citizens of Tulsa by appointment. And effective immediately, these services are being made available, for free, through the M.e.t. to the following areas:

Bixby, Broken Arrow, Claremore, Collinsville, Coweta, Glenpool, Jenks, Owasso, Sand Springs and unincorporated Tulsa County.

- Oil Based Paints and Paint Thinners
- Flammable Liquids
- Lawn Chemicals
- Automotive Fluids
- Cooking Grease
- Aerosols
- Household Cleaners
- Pool Chemicals

Items Not Accepted at the Household Pollutant Permanent Facility

- Commercial Waste
- Asbestos
- Radioactive Materials
- Unknown Materials or Substances
- Ammunition/Explosives (*call the non-emergency police number*)
- Latex Paint
- Food or Organic Waste
- Compressed Gas Cylinders
